Sub: Deliberate Negligence of NRC authority in verifying the documents in 208 NRC Sewa Kendra of 13 districts in Assam.

Sir,

With reference to the above, I on behalf of Assam Pradesh Congress Committee would like to draw your attention to the following few lines for your immediate necessary action.

1. That after Publication of the Part of the draft NRC in Assam on the midnight of 31st Dec/2017 it has now come to light that in 208 NRC Sewa Kendra of 13 districts the work of verification had not done properly. In fact in those centers, only few applications were verified as a result in those areas the names of only 10% population have appeared in the 1st Part of the draft.
2. It is very simple that if Proper verification was done, under no circumstances the names of 90% population would be left out.
3. The names of the districts where the said 208 nos. of NRC Sewa Kendra falls are: -
 1. Darrang, 2. Morigaon, 3. Naogaon, 4. Goalpara, 5. Dhubri, 6. Cachar,
 7. Karimganj, 8. Hailakandi, 9. Kokrajhar, 10. Barpeta, 11. Mancachar,
 12. Part of Nalbari and 13. Bongaigaon.
4. From the apparent view of the above situation, it reveals that religious minority and linguistic minority people are Pre-dominant in the above 13 districts. Therefore utmost care should have been taken in verifying the documents of the applicants of the above 13 districts. But it is not understood why this was not done and this very slow of progress of NRC updating was not traced, at the regular monitoring system. I demand an enquiry in this matter.
5. No doubt there is Procedure for entering the names in NRC, whose names are left out. Though verification of the remaining 1.39 Crore applications would be taken up in the 2nd phase, even then it is a matter of serious concern that in above 13 districts the names of 90% people are left out.
