Sir,

With reference to the above, this is to bring your notice the following few lines for your immediate intervention and necessary action.

1. That sir, after violating the Model Code of Conduct of election in Assam by Union Minister Sri Nitin Gadkari and Sri Sarbadanda Sonowal, Chief Minister of Assam by announcing number of mega projects for Assam on 24th October, 2016, as referred by our letter dated 25/10/16, today again Sri Himanta Biswa Sarma, Minister of Health and Education, Assam made some announcement at a public meeting held at Dongkamokam of Baithalangso LAC where by-election is scheduled to be held on 19th November, 2016.
2. Today, Sri Sarbananda Sonowal, Chief Minister of Assam and Sri Himanta Biswa Sarma, Minister of Health and Education, Assam, while addressing a public meeting at Dongkamokam, Sri Himanta Biswa Sarma, as Minister of Health and Education announced as follows –
 - A) To appoint 1100 Nos. of Youths of Baithalangso and Karbi Anglong in Diphu Medical College.

- B) To set-up one Hill University at Karbi Anglong district, work for which will be started within six months.
- C) To set-up one Engineering College at Baithalangso.

All the above announcements are going to influence the minds of voters, as such it is a gross violation of Model Code of Conduct and we the Assam Pradesh Congress Committee demand you immediate action on Sri Himanta Biswa Sarma and also urge upon you to restrain him from making further election campaigns for the interest of holding free and fair poll.

3. Further, we urge upon you to restrain the Govt. of Assam from giving different advertisement in print and electronic media with photographs of Chief Minister of Assam and other departmental Ministers announcing schemes, benefits etc. to the public during the period upto 19th November, 2016, as these are also violating the Model Code of Conduct.

In view of the above facts and circumstances, I, on behalf of Assam Pradesh Congress Committee, demand you to take immediate appropriate action on the above points.
